PROGRESS:

- Cayce is a Standard Performing Agency with a score of 76% of its last Assessment from HUD.
- The current occupancy rate is 95%.

PROGRESS:

- Established economic and self-sufficiency opportunities for residents, by enlisting community partners and creating programs that foster economic independence and self-sufficiency.

- Provided opportunities for residents to participate in many economic development opportunities with community partners.
- Hosted financial literacy workshops
- Target youth for employment, education and life skills programs.

- CH ensures that team members participate in fair housing training annually.
- Standard Operating Procedures for Grievance Hearings were developed to ensure that residents are prepared and have a fair hearing process.
